17 June 1945

1. Fol named pers (w) are reld from asgmt and dy this sta, are asgd Shipment No indicated and WP o/a 20 June 45 by mil acft to PAE Hamilton Fld Calif via the route specified by the CG, ATC, RWAT to the CO thereof for TD, thence to an overseas destination by air. Instructions issued by the Processing Operations Off of this activity, relative to route and auth intermediate stations, while enroute to PAE (Operations Orders) are hereby included as an integral part of this order.

This is a PCS with TD enroute. Dependents will not accompany nor join pers at any assembly point, staging area or port of aerial embarkation, TPA is not auth. Except as may be necessary in the transaction of official business, individuals are prohibited from discussing their overseas destination, even by shipment number. Each individual has been indoctrinated in matters of security and censorship of all activities of pers under movement orders; and has been instructed not to file safe arrival telegrams with commercial agencies while enroute to or at overseas destination.

Per diem is prescribed in accordance with provisions of Circular No 260 WD, 1944 and Section II, Circular No 356, WD 1944. For travel by rail and for periods of delay not incident to travel by air at stations where qrs and rat are not available, enroute to final overseas destination, EM will be paid monetary travel alva in lieu of qrs and rat as prescribed by AR 35-4810.

O are reld from asgmt to qrs in HQ upon date of departure. Married O were not usgd adequate qrs while at this sta.

Pers will use APO 14668, c/o Postmaster, San Francisco Calif, suffixed by the last two letters of the shipment no to which asgd (example: APO 14668-AI). Immediately upon arrival overseas and upon asgmt to an orgn, pers will use the address of the troops at that place and will furnish their perm APO and cable addresses to their friends, relatives and publishers by forwarding WD AGO Forms 971 (V-mail change of address form) and to the theatre postal officer by dispatching WD AGO Form 204 (Notice of change of address).

Clothing and equipment are prescribed in accordance with List "C" of Individual Clothing and Equipment Lists A to K, 15 November 1943, as amended. Baggage to accompany pers by air will not exceed weights as reflected on line e of weight chart of lettered column M of WD Pamphlet 38-6, 15 Jan 45, as amended.
